



## TERMS AND CONDITIONS OF TENDER NOTICE

01. The Tenders should be registered under GST and shall append a copy of PAN Card/GST No. with the tender, if applicable.
02. Tenders shall be submitted without any overwriting or any mutilation.
03. Satisfactory performance report and Experience Certificate, if any, from the Department/organisation concerned where such services are already being provided may also be furnished.
04. No conditional Tender shall be accepted. The Committee concerned reserves right to accept or reject any tender/quotation without assigning any reasons (s) thereof.
05. All Terms and Conditions of NIT shall also form part of agreement.
06. The successful Tenderer shall be responsible for execution of the contract in full and shall not in any case assign or sublet contract allotted or any part thereof to any other party. Suitable penalty upto 10% of the total value of the contract shall be imposed for any deviation from contractual obligation on merits of each besides forfeitures of Earnest Money deposits.
07. The Institute reserves the right to terminate the contract at any time, if there is any laxity in service/delivery of the contract.
08. Tender must be accompanied with CDR of Rs.5,000/- (Rupees five thousand) only pledged in favour of the Financial Advisor & Chief Accounts Officer, J&K IMPARD without which the tender shall not be accepted.
09. The contract shall be valid for a period of two years from the date of issuance of the formal Rate Contract or till such time the new Rate Contract for succeeding year is finalized.
10. Any dispute which may arise during the course of the contract shall be mutually settled by the Contract/Purchase Committee, J&K IMPARD and the contractor and the decision taken thereof shall be binding upon both the parties.
11. The performance of the contractor for Laundry works will be monitored strictly under the supervision of the Hostel Warden.
