

Tenders shall be opened within 10 days from the date of issuance of the tender in the Office Chamber of Joint Director, J&K IMPARD, Srinagar/Jammu in presence of the tenderers who wish to be present. Tenders are to be deposited in the Tender Box which will be available in the Office Chamber of Administrative Officer, IMPARD, Srinagar/Jammu on all working days. In case of any change in the schedule of opening of tenders, the same will be communicated to the tenderers on their phone/email.

The tenderer who have already submitted the tender for the above specifications shall not need to submit the tender again.

Terms & Conditions

- i) Payment shall only be released after proper verification of items supplied/installed as per specifications.
- ii) Bill in triplicate may be forwarded for arranging payments.
- iii) The last date and time for submitting tender is January 10, 2018 at 03.00 p.m. The tender shall be opened on 11th of January, 2017 in the office chambers of Joint Director, IMPARD.
- iv) Validity of tender shall be five months from the date of publication of the tender.
- v) The successful tenderer would be required to provide service and maintenance facilities for the items quoted at the place of installation. In case after sale and service is provided by the separate agency/third party, it should either be an authorised service centre or certified by the Original Equipment Manufacturer (OEM).
- vi) The rates quoted shall be inclusive of all taxes, levies, toll charges for extending of warranty, etc. including testing charges.
- vii) Earnest money is liable to be forfeited and tender is liable to be rejected if the tenderer withdraws or amends or derogates from the tender in any respect within the validity of tender.
- viii) No payment will be made in advance for any supplies under this tender.
- ix) The valid documentary proof of VAT Registration No. and details of Income-tax Registration (PAN) should be submitted alongwith the quotation clearly and separately.
- x) Delivery and installation of the items are to be completed within 21 days from the date of confirmed purchase order. If any delivery does not happen within 21 days, the department reserves right to give supply order to the next tenderer.
