



TERMS AND CONDITIONS

1. The Tender is to be submitted under "**TWO BID SYSTEM**" viz, two separate sealed covers one containing the '**Technical Bid**' and other containing '**Commercial Bid**'. Both the bids are to be packed in one sealed cover clearly written on it '**Tender of 3.5 KVA Sine Wave UPS**' batteries and Voltage Stabilizer. The Commercial bid shall be opened in case of those tenders which qualify the **technical bid** parameters which inter-alia include the following:
 - (a) **An earnest money of Rs. 20,000/- (Rupees Twenty thousand only) in the shape of a CDR may be appended with the tenders in the Technical Bid envelop pledged to FA/CAO, IMPARD, Srinagar, without which no tender will be accepted. The earnest money shall be refundable to the unsuccessful tenderers within two weeks from the date of acceptance of the lowest approved tender(s).**
 - (b) In case of Authorized Supplier/Dealers, the **Tax Returns of Income Tax and Service Tax of last year (2015-16)** must be enclosed in the Technical Bid Envelop alongwith a copy of valid **TIN Number**, without which the 'Commercial Bid' shall not be accepted.
 - (c) Authorized Dealership Certification of the Concerned Company must be appended with the Tender in the Technical Bid Envelop.
 - (d) The firm should be ISO registered & copy of same be enclosed.
2. The sealed tenders should reach the Office of FA/ CAO, J&K Institute of Management, Public Administration & Rural Development (IMPARD), M.A., Road, Srinagar within 15 days from the date of publication. The sealed tenders shall be opened and examined by a Committee comprising of Joint Director, FA/CAO and Deputy Director (Srinagar), HAT & AO on 4th October, 2016 at 01.00 p.m. in the office chamber of FA/CAO, IMPARD.
3. The tenders of other specifications except as cited above shall not be entertained. The tenders must therefore indicate detailed specifications for the quoted item.
4. Tendering Parties may quote the rates of item clearly indicating the details of taxes applicable in %ages and figures in Rupees. Accordingly, J&K IMPARD shall be at liberty to place supply orders to any agency depending upon the rates quoted by them and fulfillment of other terms and conditions by each tendering agency.

5. The item shall have to be delivered & installed by the successful tenderer(s) at JKIMPARD, Srinagar without charging any overheads on the quoted rates for installation and commissioning of the supplied item. The rates are FoR Srinagar.
6. A warranty period of not less than two year from the date of installation of the item shall be accepted. In case of any malfunction requiring repair/replacement, the supplier shall have to repair/replace the whole system or the part thereof depending on the nature of fault, at his own cost during warranty period.
7. The supplier shall impart demonstration and training of the item free of cost at the time of installation.
8. The successful tenderer shall be bound to supply the required items within a period not exceeding 07 days as per the approved rates, specifications. The lowest approved rates however shall remain valid for a period of 01 month.
9. The firms shall certify that the item is genuine as per specification and of reasonable rates.
10. The Institute reserves the right to accept or reject any tender or any part thereof without assigning any reason.
11. The payment shall be released after proper verification on account of technical specification check by the concerned technical expert of the Institute & installation/ commissioning of the item.
12. Any damage during transition shall be the responsibility of tenderer or shall replace at his own risk and cost.
13. Non Supply of items by the successful tenderer shall forfeit of CDR.
14. Any dispute shall be dealt by the courts in J&K.
