INTRODUCTION:

Gender Equality depends on democratic and gender-sensitive governance since typically women, who are or feel marginalised from the public sphere and administration do not feel empowered to take action or participate in governance. More importantly, they do not take steps to make changes to ensure that governance is gender-sensitive. As a result, laws, policies and government institutions do not reflect the needs of all citizens, nor may they be conducive to encouraging progress, and protecting women's rights. The Government promotes the rule of law, addresses priorities and formulates decisions based on broad consensus, including especially the concerns of the poorest and the most vulnerable in society.

Responsive governance examines the manners in which governance processes can be understood through a gendered framework.

The Gender Responsive Governance tries to analyse the social and economic difference between men and women and tries to inculcate the perspective which accepts that men and women may have some overlapping needs and interests but that their differing life experiences and unequal distribution of responses and resources between them will also give them Gender Special needs and interests which may at times conflict. The Gender sensitive approach therefore means being conscious of the gender needs to understand the social relations between men and women and to take these into account before embarking on interventions. Therefore quality of being fair, just and right to men and women is gender equity and it includes fairness and justice between women and men in the distribution of responsibilities, access to resources and control over resources and access to benefits.
